**Steward Health Mulls MOB Sale**

Steward Health Care System, LLC intends to offload 11 of its medical office buildings (MOBs) in Brighton, Dorchester, Foxborough, Fall River, Brockton, Taunton, Methuen, and Ayer, lease the real estate back, and use the proceeds for its hospital operations. Steward spokesman Chris Murphy said, "It's going back into the [Steward] system." We're selling our medical office buildings because we're not a real estate company. Our focus is on running hospitals and taking care of our patients." No formal asking price has been set, but the sale would probably yield tens of millions of dollars in cash.
